ORDINANCE NO. 12-02-124

AMENDING ORDINANCE NO. 99-10-021, OTHERWISE KNOWN AS AN ORDINANCE DECLARING THE MUNICIPAL WATERS FROM SITIO CARATAO TO SITIO KAPULAWAN, BARANGAY BALATASAN, BULALACAO, ORIENTAL MINDORO AS MUNICIPAL FISH SANCTUARY AND PROVIDING PENALTY FOR ANY VIOLATION THEREOF

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Section 1 of Ordinance No. 99-10-021 is hereby amended to read as follows:

"Section 1. There is hereby established a Municipal Fish Sanctuary in Barangay Balatasan covering a restricted area of 178.98 hectares which shall be covered by the following coordinates:

- From latitude 12°19'20.1" longitude 121°21'40.6"
- To latitude 12°19'8.32" longitude 121°21'20.9"
- To latitude 12°18'99.8" longitude 121°21'6.4"
- To latitude 12°18'9.7" longitude 121°21'28.6"
- To latitude 12°18'18.0" longitude 121°21'48.0"
- To latitude 12°18'19.8 longitude 121°21'51.7"





SEC. 2. This Ordinance shall take effect ten (10) days after its posting.


