ORDINANCE NO. 10

REQUIRING PERSON/PERSONS TO PAY PERMIT FEES, CEMETERY RENTALS, SERVICE FEES, FEES ON MARRIAGE SOLEMNIZE OUTSIDE THE OFFICE OF THE MAYOR, ISSUANCE OF BIRTH CERTIFICATES, BRANDING OF LARGE CATTLE OUTSIDE THE MUNICIPAL COMPOUND AND PROVIDE FINES AND PUNISHMENTS FOR EVERY VIOLATION THEREOF.

Be it Ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in Session Assembled.

SECTION 1. There shall be paid to the Municipal Treasurer for every Permit issued by the Municipal Mayor on the following;

- A. Marriage Solemn outside the Office of the Mayor - - - P 10.00 P.Sol.
- B. Issuance of Birth Certificate - - - - - P 10.00 p.Child
- C. Service Fee on large cattles branded outside the Municipal Compound - - - - - P 2.00 P. H.
- D. Cemetery Rentals:
 - 1. Children - - - - - P 5.00 p. th.
 - 2. Adult - - - - - P 10.00 P. b.
 - 3. Exhumation of Cadaver - - - - - P 10.00 p. b.
 - 4. Removal of Cadaver - - - - - P 10.00 p. b.
 - 5. Transfer of Cadaver to other places outside the Municipality - - - - - P 50.00 "
 - 6. Construction of Nitse (Pantion) - - - - - 20.00 "

Provided however, effective January, 1982 all rentals for 5 years and to be removed for 5 years must be surveyed to determin the rentals to be paid. Provided furthe, if the owner of the dead is outside jurisdiction, the same must be modified of the remains, Provided, further more, if he fails to remove the remains of the dead person, he will be required to pay another rentals for five years, i he fails to pay the rentals provided for, it is up for the Municipal government to decide on the matter.

SECTION 2.-Violation of this Ordinance or parts thereof, shall be fined the amount of P 50.00 to P 200.00 and an imprisonment of 5 days to 30 days or both such fine and imprisonment at the discretion of the court;


SECTION 3. Ordinance or Ordinances inconsistent with the Provisions of this Ordinance are hereby repealed or modified accordingly;
