**ORDINANCE NO. 16-09-168**

**AN ORDINANCE ADOPTING "ALWAYS WALK RIGHT POLICY" IN BULALACAO, ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1. STATEMENT OF POLICY.** It is a policy of the Local Government Unit of Bulalacao, Oriental Mindoro to maintain orderliness in all public facilities in order to promote peace and order, public safety and tourism development.

**SEC. 2. TITLE.** This Ordinance shall be known as Always Walk Right Ordinance of 2016 of Bulalacao, Oriental Mindoro.

**SEC. 3. PRESCRIBED ACTIVITY.** All users, residents or non-residents of Bulalacao, Oriental Mindoro of walkways, pathways, alleys, stairs, footbridges and sidewalks, shall always walk right in such public facilities.

**SEC. 4. PENALTY.** Any person who shall violate this Ordinance shall be penalized with the following manner:

- a. First Offense - Fine of PhP250.00 or community service of 1 day
- b. Second Offense - Fine of PhP500.00 or community service of 2 days
- c. Third Offense - Fine of PhP750.00 or community service of 3 days

**SEC. 5. ENFORCEMENT.** This Ordinance shall be implemented thru citizen's arrest as such, any bona fide resident of the Municipality may bring any violator to authorities who will coordinate for the enforcement of appropriate penalty upon finding out that a violation was indeed committed. All payments of fine shall be issued with official receipt by the Municipal Treasury Office.

**SEC. 6. INFORMATION DISSEMINATION.** All government officials and employees thru the heads of offices, agencies, institutions or organizations shall extend necessary efforts in disseminating this information to all. In addition, copies of the approved ordinance shall be posted in all barangay halls and bulletin boards of the Local Government Unit of Bulalacao, government institutions and non-government institutions or in conspicuous places of the Municipality.


**SEC. 7. REPEALING CLAUSE.** Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.


**SEC. 8. EFFECTIVITY CLAUSE.** This Ordinance shall take effect immediately.

**ENACTED** this 30<sup>th</sup> day of September, 2016, Bulalacao, Oriental Mindoro.


