RESOLUTION NO. 53

The Sangguniang Bayan of Bulalacao, on motion of Hon. Wilfredo F. Embile,
seconded by Hon. Amparo S. Gregorio,

RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 9 ✓

ORDINANCE NO

REQUIRING OWNERS AND CAPTAINS OF BATILS, MOTOR BOATS, BASNIC, BARDGE, LCT
AND SHIPS, ANCHORING WITHIN THE TERRITORIAL WATERS OF BULALACAO, ORIENTAL
MINDORO TO PAY ANCHORAGE FEE.

WHEREAS, there are Motor Boats, Batils, Bardge, LCT, and Ships, anchoring
in the Municipal water of Bulalacao, Oriental Mindoro;

WHEREAS, the previous rate of anchorage imposed to the above sea Trans-
portation is very low as compared to the anchorage fee imposed by other Muni-
cipalities;

WHEREAS, anchorage fee needs to be increased in order to help the Municipality raise its revenues;

WHEREAS, in order to regulate the payment of anchorage fee in this town, the Sangguniang Bayan of Bulalacao hereby Ordains that:

Section 1.- All owners and captains of Batils, Motor boats, barge, LCT and Ships anchoring within the Territorial waters of Bulalacao, Oriental Mindoro are hereby required to pay Anchorage Fees not to exceed the rate enumerated hereunder:

- a) Motor Boats carrying passengers & plying Bulalacao-San Jose and vice versa - ₱25.00 per anchor
- b) Basnig & other big fishing boats - 20.00 " "
- c) Batils Loading Commercial cargoes - 20.00 " "
- d) Barge, LCT and Ships - 50.00 " "

Section 2.- Violation of this Ordinance or part thereof, shall be fined the amount of ₱50.00 to ₱200.00 and an imprisonment of 15 days to 30 days or both such fine and imprisonment at the discretion of the Court.

Section 3.- Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4.- This Ordinance shall take effect immediately upon its passage.
