### RESOLUTION NO. 05-10-137

EARNESTLY REQUESTING THE SECRETARY, DEPARTMENT OF EDUCATION THROUGH THE SCHOOLS DIVISION SUPERINTENDENT, PROVINCE OF ORIENTAL MINDORO TO ABSORB EIGHT (8) LOCALLY FUNDED TEACHERS INTO THE NATIONAL ROLL BY ALLOCATING NEW TEACHING ITEM POSITIONS FOR BULALACAO NATIONAL HIGH SCHOOL MAUJAO EXTENSION CLASS AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

**"WHEREAS,** the establishment of Bulalacao National High School (BNHS) Maujao Extension Class five years ago was a big burden on the coffer of Bulalacao considering that all its operating expenses including the salaries and other emoluments of teachers were all taken from the local funds to the impediments of other developmental projects of this Municipality;


**"WHEREAS,** within its five years of operation, the BNHS Maujao Extension Class is now catering first to fourth year students that it is timely and important to absorb its eight (8) teachers pursuant to the Department's policy which states that any locally funded school be automatically absorb by the agency after five years of its operation;


**"WHEREAS,** the immediate consideration of the abovementioned request would truly benefit both the BNHS Maujao Extension Class and the Local Government Unit of Bulalacao, Oriental Mindoro; Now, therefore, be it


