ORDINANCE NO. 93-03-039

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 16, SERIES
OF 1992

Sponsored by: Hon. Eduardo A. Buruanga
Chairman: Committee on Ordinances and Legal Matters

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental
Mindoro, that:

SECTION 1. Section 1 of Ordinance No. 16, series of 1992 is
hereby amended to read as follows:

"SECTION 1. Regulated Acts. No person shall
extract, quarry or haul sands from within
the shorelines of Kaburayan River to Tambi-
Tambi pt., Bulalacao, Oriental Mindoro, for
whatever purpose at all times."

SECTION 2. Section 2 of the same Ordinance is hereby amended
as follows:

"SECTION 2. Extracting, quarrying or hauling
of sands from areas not covered in the above
mentioned restricted areas may be done, pro-
vided that a permit therefor from the Mayor
must first be secured and the corresponding
fees or taxes being required by the existing
tax ordinances of this Municipality be paid.
Provided, further, that the extracted sand shall
be for personal use only and shall not exceed
the maximum limitation of five hundred (500)
cans per household."

SECTION 3. Section 3 of the same Ordinance is hereby amended
as follows:

"SECTION 3. Any person who violates any provision of this Ordinance shall be punished by a fine of Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of six (6) months, or both fine and imprisonment at the description of the Court."

SECTION 4. All Ordinances inconsistent hereof are hereby repealed, modified accordingly.

SECTION 5. This Ordinance shall take effect ten (10) days after its posting.
