"WHEREAS, last SY 2002-2003 the Local Government of Bulalacao (LGU) funded the salaries of three (3) teachers teaching at Bulalacao National High School Extension at Maujao and four (4) teachers teaching at the Bulalacao National High School Extension at San Roque, Bulalacao;


