RESOLUTION NO. 20-03-243

DECLARING A STATE OF CALAMITY IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO DUE TO CORONA VIRUS DISEASE 2019 (COVID-19)

"WHEREAS, pursuant to Section 15, Article II of the Philippine Constitution, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

"WHEREAS, on March 8, 2020, the President of the Republic of the Philippines through Proclamation No. 922 declared a State of Public Health Emergency because of the outbreak of COVID-19 which constitutes an emergency that threatens national security enjoining all government efforts to intensify immediate response and measures and enforce quarantine and disease control prevention measures;

"WHEREAS, on March 16, 2020, President Rodrigo Roa Duterte under Proclamation No. 929 declared a State of Calamity throughout the Philippines due to Corona Virus Disease 2019 enjoining all government agencies and local government units (LGUs) to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the threat of COVID-19;

"WHEREAS, the Municipal Development Council (MDC) together with the Municipal Disaster Risk Reduction and Management Council (MDRRMC), the Philippine National Police, Philippine Army, Bureau of Fire Protection, the Philippine Coast Guard and all other government agencies conducted a meeting on March 17, 2020 to discuss and formulate strategies and disaster preparedness and response efforts to prevent the spread and transmission of COVID-19 and to continue to provide basic services to the affected population thereafter, it recommended the declaration of the State of Calamity;

"WHEREAS, the declaration of the State of Calamity in the Municipality of Bulalacao afford ample latitude to utilize appropriate funds including the Quick Response Fund (QRF) to sustain the imposition of Enhanced Community Quarantine in the entire Municipality; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Declare a State of Calamity in the Municipality of Bulalacao, Province of Oriental Mindoro due to Corona Virus Disease 2019 (COVID-19);
