RESOLUTION ENDORSING THE INTENTION OF THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO OF ACQUIRING THE AMOUNT OF SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP7.5M) TO BE USED FOR THE PURCHASE OF HEAVY EQUIPMENTS AMOUNTING TO SIX MILLION PESOS (PHP6M) AND CONSTRUCTION AND REHABILITATION OF FARM TO MARKET ROADS IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1.5M)

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro intends to acquire loan from the Land Bank of the Philippines, Roxas Branch in the amount of Seven Million Five Hundred Thousand Pesos (Php7.5M) to be used for the purchase of heavy equipments and construction and rehabilitation of farm to market roads in the amount of Php6M and Php1.5M respectively;

"WHEREAS, the Municipal Government intends to acquire the following heavy equipments; to wit:


i. Dumptrucks	-	4 units
ii. Grader	-	1 unit
iii. Back hoe	-	1 unit
iv. Roadroller compactor	-	1 unit
v. Bulldozer	-	1 unit
vi. Tractors	-	2 units
vii. Fire truck	-	freight cost only,


"WHEREAS, the Municipal Government likewise appropriated One Million Five Hundred Thousand (Php1.5M) for the construction and rehabilitation of San Juan Farm to Market Road; Now, therefore, be it


