### **RESOLUTION NO. 05-08-101**

**EARNESTLY REQUESTING THE HONORABLE JAMBY MADRIGAL, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF 3-CLASSROOM BUILDING WITH COMPLETE FACILITIES AND AMENITIES AT BULALACAO NATIONAL HIGH SCHOOL BENLI EXTENSION CLASS LOCATED AT BARANGAY BENLI, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO TO BE NAMED AS SENATOR JAMBY MADRIGAL TYPE SCHOOL BUILDING**

**"WHEREAS,** it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that basic and quality education be made accessible to all;

**"WHEREAS,** the Bulalacao National High School Benli Extension Class was initially established and operated last June, SY-2005-2006 in order to cater the secondary students from the remotest barangay of Bulalacao who are all Mangyans so as to provide them all means to continue studying which is necessary to make them an active and responsible citizens of this Municipality and of the country as a whole;


**"WHEREAS,** with the strong belief that education is the major tool to make our upland brothers and sisters more productive and responsible, the Municipal Government of Bulalacao initiated the opening-up of Benli Extension Class for secondary level however, due to financial constraints it could not readily provide the additional and concreted classroom building added to the salaries of teachers assigned thereat;


"WHEREAS, Senator Jamby Madrigal is noted for her being concerned on the future of the youth that the above request is believed to be considered and prioritized; Now, therefore, be it


**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Honorable Jamby Madrigal, Senator, Republic of the Philippines to allocate the necessary funds for the construction of 3-classroom building with complete facilities and amenities at Bulalacao National High School Benli Extension Class located at Barangay Benli, Municipality of Bulalacao, Province of Oriental Mindoro to be named as Senator Jamby Madrigal Type School Building;
