**MUNICIPAL ORDINANCE NO. 23-05-351**

AN ORDINANCE IMPOSING SPECIAL PERMIT FEE TO BE ISSUED BY  
THE OFFICE OF THE MUNICIPAL MAYOR IN THE AMOUNT OF FIVE  
HUNDRED PESOS (PHP500.00) PER DAY FOR THE CONDUCT OF ANY  
SPECIAL EVENTS OR ACTIVITIES WITHIN THE MUNICIPALITY OF  
BULALACAO, ORIENTAL MINDORO

WHEREAS, Article X, Section 5 of the 1987 Constitution states that  
"each local government unit shall have the power to create its own resources  
of revenues and to levy taxes, fees and charges subject to such guidelines  
and limitations as the Congress may provide, consistent with the basic policy  
of local autonomy. Such taxes, fees, and charges shall accrue exclusively to  
the local government";

**WHEREAS**, Section 129 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that "Each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees and charges subject to the provision herein, consistent with the basic policy of the local autonomy. Such taxes, fees and charges shall accrue exclusively to the local government unit";

**WHEREAS**, Section 132 of the same law above, states that "The power to impose tax, fee or charge or to generate revenue under this Code shall be exercised by the Sanggunian of the local government unit concerned through an appropriate ordinance";

**WHEREAS**, the Revenue Code of 2004 of the Municipality of Bulalacao, Oriental Mindoro has a limited and vague information regarding the imposition of fees of certain events and/or activities that are being held and/or operated within the Municipality;

**WHEREAS**, it is ideal and advantageous to the local autonomy of this municipality to require all the individuals and/or organizations that are planning to conduct any kind of special events and/or activities within the municipality to secure and pay for the special permit fee to be issued by the Office of the Municipal Mayor, it shall not only compensate any of the expenses of the operating and maintenance services of the vicinity or area to be used but also it would provide income to the municipal government;

**NOW, THEREFORE, BE IT ORDAINED**, as it is hereby ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro, that:

**Section 1. Statement of Policy.** It is the policy of the Local Government Unit of Bulalacao to undertake initiatives and ponder a systematic way of gaining local income to contribute to the progress of the municipality as a whole.

**Section 2. Title.** This Ordinance is entitled as stated and shall be also known as "2023 Special Permit Fee for the Conduct of Any Special Events or Activities Ordinance of Bulalacao".

**Section 3. Scope/Coverage.** This Ordinance covers all individual/organizations who are intending to conduct or operate any kinds of special events or activities within the territorial jurisdiction of the Municipality of Bulalacao, Oriental Mindoro.

**SECTION 4. Definition of Terms.** As used in this ordinance, the following terms shall mean:

- a. **Special Permit** refers to a permit granted by the Municipal Mayor to a qualified individual or organization to allow them to conduct the operation of any kind of special events or activities within the jurisdiction of Bulalacao.

- b. **Fee** refers to a charge amounting to Five Hundred Pesos (PhP500.00) per day for the issuance of the special permit.
- c. **Municipal Treasury Office** refers to the office of the Local Government Unit of Bulalacao who shall be in charged in collecting the fee of the special permit and issuance of official receipt of the amount being paid.
- d. **Operator** refers to any of the owner, manager, administrator, or any other person who operates or is responsible for the conduct of the events/activities within the jurisdiction of Bulalacao.
- e. **Special Events/Activities** refers to a temporary outdoor activity occurring one or more consecutive days in a year, and maybe located in a temporary structure or tent within the jurisdiction of Bulalacao, for activities that include but are not limited to group activities, receptions and ceremonies, music and related festivals or concerts, theatrical exhibitions, food sales, entertainment, sporting events, fund raisers, outdoor sales or other similar activities such as:
- f. **Advertisements** generally considered a public communication that promotes a product, service, brand or event.
- g. **Promotional Activities** the techniques that marketing teams use to increase awareness of their brand, products and services.
- h. **Hang Streamers** are long narrow flag, banner, or pennant that which streams out, or hangs or floats at full length, applied to anything long and narrow, as a ribbon.
- i. **Parade** is a public procession, especially one celebrating a special day or event and including marching bands and floats.
- j. **Motorcade** is a line of cars traveling together, usually slowly and ceremonially.

**Section 5. Imposition of Fee.** The Municipal Treasury Office shall collect Five Hundred Pesos (PhP500.00) per day in every special permit issued by the Office of the Municipal Mayor.

**Section 6. Time and Manner of Payment.** The fee imposed herein shall be due and payable upon the application of the special permit for the conduct of the special events/activities. The special permit shall only be granted upon the issuance of the receipt from the Municipal Treasury Office stating that the imposed fee has been paid.

**Section 7. Administrative Provisions.**

- a. **Application for Special Permit.** A written application from the operator for a permit to operate a special event/activity shall be filed with the Office of the Mayor in three (3) copies. The form for the purpose shall be issued by the same office and shall set forth the requisite information including the name and address of the application, the description of the intended special event/activity, the place where the special event/activity shall be conducted and such other data or pertinent information as may be required.

**Section 8. Penalty.** Any violation of the provision of this ordinance shall be punished by a fine:

- 1<sup>st</sup> offense - PhP1,000.00
- 2<sup>nd</sup> offense - 1,500.00
- 3<sup>rd</sup> offense - 2,500.00

**Section 9. Repealing Clause.** Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

**Section 10. Separability Clause.** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.


**Section 11. Effectivity.** This ordinance shall take effect upon its approval.
