RESOLUTION EARNESTLY SEEKING THE TRUST AND CONFIDENCE OF DIRECTOR ANTONIO G. GERUNDIO, REGIONAL DIRECTOR, DEPARTMENT OF AGRICULTURE-MIMAROPA, 4th FLOOR, ATI BUILDING, ELLIPTICAL ROAD, DILIMAN, QUEZON CITY, TO DOWNLOAD THE THIRTY EIGHT MILLION AND EIGHT HUNDRED THOUSAND PESOS (PHP38.8M) ALLOCATED FOR THE CONCRETING OF THE CAMBUNANG FARM-TO-MARKET-ROAD (FMR) TO THE LOCAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO AND ASSUME THE RESPONSIBILITY IN THE IMPLEMENTATION AND MANAGEMENT OF THE PROJECT

"WHEREAS, the Municipality of Bulalacao situated in the southernmost part of the Province of Oriental Mindoro is endowed with rich agricultural potential through its vast lands planted into various agricultural products like rice, corn, coconut, garlic, onion and other cash crops;

"WHEREAS, considering that our municipality is one of the major supplier of rice and corn not only in the Province of Oriental Mindoro but also to other neighboring provinces and cities, yet, the poor roads condition must have to be addressed to facilitate the mobility of people and agricultural products;

"WHEREAS, in line with the present National and Local Governments' thrust on project implementation through counterparting scheme, we can assume that the knowledge, skills and right attitude learned from being a recipient, dynamic partner and stakeholder of devolved projects such as from the DA-InfRES and DSWD-KALAHI-CIDSS projects, we are capable enough to assume the responsibility to implement and manage road opening, rehabilitation, construction and concreting, inasmuch as we have the available equipments and current capable technical staff to manage the work,

"WHEREAS, it is respectfully requested from your good office that the Thirty Eight Million and Eight Hundred Thousand Pesos (Php38.8M) allocated for the construction of the Cambunang Farm To-Market Road (FMR) be downloaded to the LGU-Bulalacao, Oriental Mindoro which will assume responsibility for the implementation of the said project in response to the long time and recurring clamor for good roads condition of the marginalized farmers to be served.
