"RESOLUTION NO. 93-07-055

REQUESTING THE GOVERNMENT OF JAPAN, THROUGH THE JAPAN INTERNATIONAL COOPERATION AGENCY (JICA) TO GRANT ASSISTANCE IN THE CONSTRUCTION OF SPRING DEVELOPMENT PROJECT IN BARANGAY SAN ROQUE, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Japan, in the name of goodwill and international solidarity has been extending packages of grant assistance to the Philippines, to help the latter on its development, reconstruction and rehabilitation efforts;

"WHEREAS, Japanese Ambassador to the Philippines Hirokazu Arai said last October 23, 1992 that " I can assure you that my government will remain focused on directly addressing the plight of farmers in rural areas and the urban poor through extending grant aid to the Philippines";

"WHEREAS, provision of available potable water is one of the basic services that the government must deliver to its constituents;

"WHEREAS, an effective water system is absolutely needed so that water, which is extremely essential for the maintenance and preservation of life, will reach every household;

"WHEREAS, notwithstanding the genuine commitment of the local officials to provide those basic services, still financial constraint becomes the major hindrance in the realization of their long time dreams of advancement;

"WHEREAS, the humble Municipality of Bulalacao, Oriental Mindoro, one of the 150 Low Income Municipalities under Executive Order No. 390 hopes that the goodwill of the Japanese people will help the economically affected people of this Municipality to overcome the difficulties and move towards better future;

NOW THEREFORE:

RESOLVED AS IT HEREBY RESOLVED by the Sangguniang Bayan to request the government of Japan, through the Japan International Cooperation Agency (JICA) to grant assistance in the construction of Spring Development project in Barangay San Roque, Municipality of Bulalacao, Oriental Mindoro.
