TAX ORDINANCE NO. 3

AN ORDINANCE AMENDING MARKET STALL FESS IN PARAGRAPH A, SECTION 5A.03 OF TAX ORDINANCE NO. 4, DATED DECEMBER 7, 1988 ARTICLE

SECTION 1. MARKET STALL FEES of Article A, Section 5A.03 of Tax Ordinance No. 4, s of 1988 is hereby ammended fromm ₱4.00 to ₱10.00 per square meter and fraction thereof;


Section 2. Violation of this Ordinance or parts hereof, shall suffer a fine of not less than ₱1,000.00 and an imprisonment of six months or both at the discretion of the Court;


Section 3. Ordinance or Ordinances inconsistent with the provision of this Ordinance are hereby repealed or modified accordingly;


Section 4. This Ordinance shall take effect immediately, 15 days after its passage;


UNANIMOUSLY APPROVED

There having no other business to be taken-up, so on motion of Councilor Nenito S. Ambong, seconded by all the members present, session is adjourned at 12:00 noon;


