“WHEREAS, for the past several months, the Municipality of Bulalacao
has been significantly affected by the impact of a severe drought due to the
absence of rainfall which resulted to dwindling water sources that presented a
major challenge to the farmers in irrigating their crops, thus, this scarcity of
water has consequently led to crop failures and a decrease in agricultural
production;
