EARNESTLY REQUESTING THE HONORABLE PIA CAYETANO, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF 3-ROOM SCHOOL BUILDING FOR UPPER YUNOT ELEMENTARY SCHOOL SITUATED IN BARANGAY NASUCOB, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that basic and quality education be made accessible to all;

“WHEREAS, Upper Yunot Elementary School in Barangay Nasucob, Municipality of Bulalacao, Province of Oriental Mindoro caters pupils of mostly composed of hanunuo mangyans, that concerted effort should be enjoined to provide them adequate school facilities conducive to learning;

“WHEREAS, the school buildings of Upper Yunot Elementary School are heavily damaged and dilapidated which poses danger to lives and properties of both the pupils and teachers alike particularly during the onslaught of bad weather condition;

“WHEREAS, there is a need to provide additional classroom building at the abovementioned school to accommodate the increasing enrollees thereof that assistance from Senator Cayetano is highly anticipated, Now, therefore, be it;
