“**WHEREAS**, Section 34 of the Local Government Code of 1991 states that Local Government Unit shall promote the operation and establishment of people’s nongovernmental organizations to become active partners in the pursuit of local autonomy;

“**WHEREAS**, Section 35 of the same law further provides that the local government units may enter into a joint ventures and such other cooperative arrangements with people’s nongovernmental organization to engage in the delivery of certain basic services, capability building and livelihood projects and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance and enhance the economic and social well-being of the people;

“**WHEREAS**, submitted and presented before this body is the application for accreditation of Samahan ng mga Maghahayop, Magsasaka, Mangingisda at Magniniyog ng Bulalacao duly registered with the Department of Labor and Employment under Registration Number ORMIN 2017-0102 dated August 17,2017;






