MINUTES OF THE SPECIAL MEETING OF THE SANGGUNIANG BAYAN OF BULALACAO,
ORIENTAL MINDORO HELD ON MAY 20, 1981 AT THE MUNICIPAL SESSION HALL.

The meeting was called to order by acting Presiding Officer Hon. Ulpiano C. Pandino after Unanimously elected in accordance with the rules of procedure.

The calling of the roll was performed by the recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also read by the recorder and there no objection so on motion of Hon. Mariano O. Aceron, seconded by Hon. Modesto O. Bacawag, the minutes stands as confirmed.

Following the rules of procedure the meeting was suspended at 9:40 to entertain the barangay catpains of this Municipality, namely: Macario Fanganiban, of Barangay San Francisco; Usig Caring of Boly; Antonio Farol of Bala-tasan; Abundio Magnay of Cambunang; Miguel Panam of San Miguel; Nicolas Im-bate of Cabugao; Antonio Santillan of San Juan and Jhony Magracia, Barangay Councilman of Maasin who brought out the problems of the ₱ 5,000.00 which was given by the National Government.

Barangay Captain Antonio Santillan claimed that until now, the amount of ₱450.00 for the labor was not given to them by MLGCD, Malencio Faminialagao, Macario Fanganiban also said that the materials of his project are lacking and the labor for the construction of the same was not also given to him. Miguel Panam, Usig Caring and Jhony Magracia likewise claimed that the materials of their projects are also lacking and the fund for the labor is not also given to them. The delay of the delivery of construction materials and the release of fund for the labor also delayed the construction of their projects. They said, Faminialagao promised them to supervise the construction of their projects and to give the fund for the labor, but the same failed to do so.

Hon. Edilberto M. Pajila in his hot and lambasting critics on the irregularities of the canvas of materials on the ₱5,000.00 said, he being a member of the committee on canvas should be notified during the time of canvas. He further said there must be something wrong and irregularity done on the ₱5,000.00 by those concerned.

He also asked Jhony Magracia of Maasin whether their project is already constructed. The Councilman from Maasin declared that a tank of the toilet and two toilet bowls could be seen in the school campus and the same has no roof and wallings. Magracia also claimed that they are still waiting for the delivery of the materials and the release of fund for the labor but Faminialagao failed to do so.

Three affidavits relative to the irregularities of the delivery of construction materials executed by barangay captains, Mar Astillo of Maasin, Miguel Pando of San Miguel and Usig Caring of Benli was submitted to this body for proper action thereof. So on motion of Hon. Modesto O. Bacawag, seconded by Hon. Wilfredo J. Bahile, the Resolution referring the affidavits to the Regional Director, Region IV, Quezon City for proper action was Unanimously Approved. An objection to that effect was made by Hon. Edilberto M. Pajila with his agreement that the Resolution must be held in abeyance for the reason that Faminialagao must be given due time to arrange the matter with the barangay captains.

At this juncture, the barangay captains as well as the Sangguniang Bayan were surprised to know that Hon. Edilberto M. Pajila has strongly objected to the enactment of the Resolution, because in the first stage of his commentaries on the ₱5,000.00 he even read this Honorable Body the requirement to be followed by Faminialagao during the canvass of the construction materials but inspite of this, the MLCOD Officer ignored it.

The Presiding Officer called for a division of the house, and election followed. Hon. Mariano Aceron, Modesto O. Bacawag, Wilfredo J. Bahile, Francisco Pandino and Manuel Merlin were in favor of the enactment of the Resolution, while Hon. Amparo S. Gregorio, Juanita T. Amparo and Perpetuo Centos were obtained. Hon. Edilberto M. Pajila is the only one who is not in favor of the passage of the Resolution. The Resolution was UNANIMOUSLY APPROVED.

The contract of the Bidding of the Bangus Fry in this Municipality was read to this Body by the Recorder. Hon. Mariano Ask the Recorder whether the money is deposited in the Office of the Municipal Treasurer. At this juncture, the Assistant Municipal Treasurer, Mr. Nachor Cabagay was summoned to this body to answer the question of Hon. Mariano O. Aceron. Mr. Cabagay said, the money is in the hand of the Municipal Mayor. He said the money is taken by the Mayor as payment of the lumber she owned used for the construction of the new Municipal building and that the same must be arranged when the Treasurer comes.

There having no other business to be transacted so on motion of Hon. Amparo S. Gregorio, seconded by Hon. Juanita Ta. Amparo, the meeting was adjourned at 12:00 in the morning.

REFERRING THE COMPLAINT OF THE BARANGAY CAPTAINS OF DULALACAO, ORIENTAL MINDORO TO THE REGIONAL DIRECTOR, MINISTRY OF LOCAL GOVERNMENT AND COMMUNITY DEVELOPMENT, 197 BONNY SERRANO ROAD, QUEZON CITY FOR PROPER ACTION.

WHEREAS, the Barangay Captains of this Municipality has appeared for the second time before this Honorable Body and complained regarding the irregularities of the delivery of construction materials and the release of fund for the labor of their projects on the ₱5,000.00 which given by the National Government, ~~of 1980~~;

WHEREAS, the first complaint done by the barangay captains to this Body was referred to the Sangguniang Panlalawigan, Calapan, Oriental Mindoro in Resolution No. 33, dated September 18, 1980 requesting that body to initiate the investigation but until now no action has been taken thereof;

WHEREAS, three affidavits were executed and submitted to this body by Barangay Captains, Mr. Astillo of Maasin; Miguel Panum of San Miguel and Usig Caring of Benli stating the irregularities of the delivery of construction materials of their projects;

WHEREAS, the Sangguniang Bayan of Dulalacao have agreed to refer these complaint to the Regional Director, Ministry of Local Government and Community Development, 197 Bonny Serrano Road, Quezon City for proper action;

NOW, THEREFORE, resolved as it is hereby resolved to refer the complaint of the Barangay Captains of this Municipality to the Regional Director, Ministry of Local Government and Community Development, 197 Bonny Serrano Road, Quezon City;

RESOLVED, FURTHER, that copy of this Resolution be furnished the Regional Director, Ministry of Local Government and Community Development, 197 Bonny Serrano Road, Quezon City for consideration and proper action and the Sangguniang Panlalawigan, Calapan, Oriental Mindoro for their information.

On motion of Hon. Modesto O. Bacawag, seconded by Hon. Wilfredo G. Embile, this Resolution was... UNANIMOUSLY APPROVED.

THERE HAVING no other business to be transacted so on motion of Hon. Arpero S. Gregorio, seconded by Hon. Juanita T. Amparo, the meeting was adjourned at 12:00 o'clock in the morning.
