RESOLUTION NO. 3

The Sangguniang Barangay of San Roque, on motion of Kagawad Paterno Ibabao, seconded by Kagawad Rolando Pagcaliwagan,

RESOLVED, to approve the following Ordinance:

ORDINANCE NO. N

DECLARING THE DAY OF SATURDAY OF EVERY MONTH AS THE MARKET DAY OF BARANGAY SAN ROQUE, BULALACAO, ORIENTAL MINDORO

WHEREAS, the usual market day of Barangay San Roque, Bulalacao, Oriental Mindoro is held every Sunday of the month;

WHEREAS, the market day of Barangay San Roque has the same market day with that of Poblacion, this municipality;

WHEREAS, because the market day of San Roque and Poblacion are held on the same day, it has been observed that mostly of the people in this and adjacent barangays and municipalities were attending the market day of San Roque, thus depriving the market day of Poblacion;

WHEREAS, in order to have a different market day between Barangay San Roque and Poblacion, the Sangguniang Barangay hereby ordains, that:

SECTION 1. The day of Saturday of every month is declared as the market day of barangay San Roque, Bulalacao, Oriental Mindoro;

SECTION 2. All people from this and adjacent barangays and municipalities are hereby enjoined to observe strictly the day of Saturday of every month as the market day of San Roque and no person shall be allowed to display, buy and sell goods in the market place during Sundays other than the day declared hereof;

SECTION 3. Violation of this Ordinance or parts hereof, shall be fined the amount of ₱50.00 to ₱200.00 and imprisonment of 10 to 20 days or both such fine and imprisonment at the discretion of the court;

SECTION 4. Barangay Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 5. RESOLVED, FURTHER, that this Ordinance be posted in conspicuous places visible to the public for their information, guidance and reference;

SECTION 6. This Ordinance shall take effect immediately;
