ALMEDA TO ALLOCATE FUNDS FOR THE INSTALLATION OF SECONDARY LINE ELECTRICAL CONNECTION AND CONSTRUCTION OF STREET LIGHTS AT THE DIVERSION ROAD CROSSING BARANGAY CAMPAASAN AND BARANGAY POBLACION BOTH IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, for over the past decades, our Government has always been prioritizing the rural electrification, it strongly believes that the provision of electric services will produce more opportunities to improve the socio-economic growth of the marginalized sectors, and it will have a greater access to basic services and better infrastructure for rural development;

**"WHEREAS**, Bulalacao is a third class municipality located at the southernmost tip of the Province of Oriental Mindoro, it has a Municipal Government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, Bulalacao has a diversion road crossing its two barangays that helps vehicles especially the huge ones traversing alternative route, thus, the increasing number of households along the area and the construction and development of infrastructure projects such as the newly constructed community hospital and evacuation center are imperatively needing supply of electricity;

"WHEREAS, the stretch of Bulalacao Diversion Road with approximately 5 kilometers, has a concern with the absence of secondary lines and street lights that would provide safety and convenience to motorists and pedestrians especially in night time;


"WHEREAS, this Sanggunian is humbly asking the National Electrification Administration (NEA) to provide assistance in allocating funds for the affirmative completion of the installation of secondary lines and construction of street lights at the aforementioned diversion road; Now, therefore, be it...






