**AN ORDINANCE REGULATING SPEED LIMITATIONS ALONG
PROVINCIAL ROAD SPECIFICALLY FROM SITIO MARADANUM,
BARANGAY CAMPAASAN TO BULALACAO RORO PORT, BARANGAY
POBLACION AND VICE VERSA IN THE MUNICIPALITY OF
BULALACAO, ORIENTAL MINDORO**

WHEREAS, speeding is the prime reason of majority of traffic
accidents, it contributes to road fatalities and is at the core of the road injury
problem as it influences both crash risk and crash severity and it significantly
affects vulnerable road users;

Section 6. Signages. The Municipal Engineering Office shall be directed to install signages indicating the allowed speed limit in the road area entering Sitio Maradanum, Barangay Campaasan and in the road area in front of the Bulalacao RoRo Port, Barangay Poblacion.

Section 7. Enforcement. Upon the approval of this Ordinance, a Traffic Management Committee shall be organized by the Municipal Mayor as the lead agency for the implementation of this Ordinance and shall be responsible for the general supervision of and coordination with support agencies and offices such as the PNP and MDRRMO.

Section 8. Penalties. The following penalties shall be imposed against violators of this Ordinance:

- First Offense - PhP500.00
- Second Offense - 1,500.00
- Third Offense - 2,500.00


Section 9. Repealing Clause. Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.


Section 10. Separability Clause. If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in full force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.


Section 11. Effectivity. This Ordinance shall take effect upon after ten (10) days of posting in at least three (3) conspicuous places in the Municipality.


