WHEREAS, an Ordinance entitled "An Ordinance  
establishing an Environmental Users Fee System in the

WHEREAS, when the said Ordinance was implemented there was a clamor in the collection of the Environmental Users Fee;

WHEREAS, the Local Chief Executive requested the Sangguniang Bayan to amend the Ordinance by lowering the amount being charged in the Environmental Users Fee;

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Item 7.1, Section 7 of Municipal Ordinance No. 21-02-283 is hereby amended to read as follows:

"7.1 Environmental Users Fee. An environmental users fee in the amount of twenty five pesos (PhP25.00) shall be collected by its designated and authorized collectors from all tourists, travellers and guest upon entering the Municipality of Bulalacao or any landing sites or entry points going to any barangays of Bulalacao. The environmental fee shall be good only for his or her entire stay in Bulalacao until his or her exit/departure from any of the barangays of Bulalacao. The Environmental Users Fee shall increase in the amount of five pesos (PhP5.00) every year but should not exceed fifty pesos (PhP50.00)."

SECTION 2. This ordinance shall take effect immediately upon approval.
