RESOLUTION NO. 157 19
(ORDINANCE NO. 6) 3

AN ORDINANCE REQUIRING ANY PERSON OR PERSONS, ANY CATCHER, PROPRIETOR, OPERATOR, ANY INDIVIDUAL FOR CATCHING BANGUS FRY WITHIN THE MUNICIPAL WATERS OF BULALACAO, ORIENTAL MINDORO, TO FILE AN APPLICATION FOR A PERMIT, PROVIDING PENALTY FOR VIOLATION:

By virtue of the authority conferred upon Municipal Councils by law, the Municipal Council of Bulalacao, in session duly assembled ordains and decrees:

SECTION I.- For the interest of the public in general, that no bidder or bidders, participants have appeared during the meeting of the auction on bid which was held on March 9, 1970, the following rules and regulations are hereby promulgated for catching Bangus Fry within the Municipal waters of Bulalacao, to wit:

(a) Any person or persons, catcher, proprietor, operator, any other individual is or are allowed to catch bangus fry in any zone or zones within the territorial waters of Bulalacao, Oriental Mindoro, shall apply for a permit therefore, to the Municipal Treasurer.

SECTION III.- Application for a permit may be denied by the Municipal Treasurer if in his opinion, the catcher, proprietor, operator, any other person or persons does not meet the requirements as embodied in this Ordinance.

~~SECTION III.- Application for a permit may be denied by the Municipal Treasurer if in his opinion, the catcher, proprietor, operator, any other person or persons does not meet the requirements as embodied in this Ordinance.~~

SECTION IV.- Upon approval of the Application, there shall be payment in the office of the Municipal Treasurer in the amount of P1.00 as permit fee.

SECTION V.- After the approval of this Ordinance and Permit has been granted, the following fees, charges, to any catcher, proprietor, operator person or persons shall pay the Municipal Treasurer the following:

1.- For every pot or jar with the capacity to hold 2,500 Bangus Fry, the amount of P1.00 be collected as tax fee.

SECTION VI.- Within the meaning of this Ordinance for catching bangus fry within the Municipal waters of Bulalacao, person or persons is or are allowed to erect, build saplad five (5) meters from the edge of the rivers or streams which is solely for the catcher only whose application and permit has been approved by the Municipal Treasurer.

SECTION VII.- That no person or persons, catcher, operator, proprietor could utilized both sides of the bank of the rivers or streams to build saplad, erect in front of other saplad, that is being granted and permitted and has been built prior to others erection.

Sagup which is another instrument for catching bangus fry be allowed and permitted to any catcher, operator, proprietor, any other person or persons to catch bangus fry, along the beach or seashore of the Municipal waters of Bulalacao, Oriental Mindoro.

SECTION VIII.- PENALTY:-Any person or persons who shall violate any of the provisions of this Ordinance, shall be punished by a fine of not more than P150.00 or imprisonment of not more than thirty (30) days or both such fine and imprisonment in the discretion of the court.


SECTION IX.- This Ordinance shall take effect upon approval of the Municipal Council.
