RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 5

AN ORDINANCE REQUIRING BARANGAY SCHOLARS TO SECURE CERTIFICATIONS IN THE OFFICE OF THE MUNICIPAL MAYOR AND THE OFFICER INCHARGE OF THE MINISTRY OF LOCAL GOVERNMENT FOR PROPER INDENTITY

WHEREAS, Bulalacao Municipal High School is owned and run by the Municipal government;

WHEREAS, pursuant to Batas Pambansa Blg. 337, otherwise known as the Local government Code, specifically provided that children of Barangay officials and elected Kabataang Barangay are free from paying their tuition and matriculation fees in public schools;

WHEREAS, in order to regulate the payment of Certifications of Barangay Scholars, the Sangguniang Bayan hereby ordains, that:

SECTION 1. Barangay Scholars, who shall enroll in the Bulalacao Municipal High School are hereby required to secure certifications in the office of the Municipal Mayor and the officer Incharge of the Ministry of Local government this municipality;

SECTION 2. Barangay Scholars mentioned in Section I hereof, shall pay the amount of ₱5.00 to the Municipal Treasurer or his authorized representatives for every clearance issued thereof;

SECTION 3. Failure of Barangay scholars to secure clearances, their scholarships shall not be honored;

SECTION 4. Ordinance or Ordinances in-consistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 5. This Ordinance shall take effect immediately;


