RESOLVED, to approve the following Appropriation Ordinance:

APPROPRIATION ORDINANCE NO. 4  
SUPPLEMENTAL BUDGET NO. 3  
FOR CALENDAR YEAR 1986

APPROPRIATING THE AMOUNT OF ₱7,926.39 TO BE TAKEN FROM THE ESTIMATED INCOME OF BULALACAO MUNICIPAL HIGH SCHOOL FOR SCHOOL YEAR 1986-1987 FOR SALARY OF ONE ADDITIONAL TEACHER.

SECTION 1. There is hereby appropriated the sum of ₱7,926.39 to be taken from the estimated income of the Bulalacao Municipal High School, due to the increase in school population from 410 to 460 students, for school year 1986-1987 for salary of one (1) additional teacher, covering the period from the month of July to December 31, 1986;

SECTION 2. This Ordinance shall take effect immediately;

RESOLVED, FURTHER, that copies of this Appropriation Ordinance be furnished Mr. Helgie Fabella, Teacher In-charge, Bulalacao Municipal High School for his information, the Provincial Treasurer and the Provincial Budget Officer, Calapan, Oriental Mindoro for review and approval.
