ORDINANCE NO. 93-05-039-A

ORDINANCE REGULATING THE ISSUANCE OF FISHING PERMIT IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

Sponsored by: Hon. Eduardo A. Buruanga
Chairman: Committee on Ordinances and Legal Matters

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. No fishing permit shall be issued to any person at this Municipality without first securing a clearance or permit for the purpose from the Municipal Agricultural Officer;

SECTION 2. The Municipal Agricultural Officer shall require the owner of any fishing gears operating in Bulalacao, Oriental Mindoro to secure clearance or permit from his office before any fishing operation can be made;

SECTION 3. A party required to secure a clearance or permit under this ordinance shall file an application therefor with the Municipal Agricultural Officer. The application shall state:

- The name, address and other pertinent circumstances of the persons, in case of an individual or, in the case of a firm, association, partnership or other entity, the name, address and other pertinent circumstances of the president, manager or officer in charge;
- The type of fishing gear to be used;

SECTION 4. The Municipal Agricultural Officer shall within seventy-two (72) hours from receipt of the application, act thereon by either issuing the clearance/permit requested or denying the same.

Denial of an application shall be in writing and shall state in brief the reason/s therefor. He shall also orient the grantees of this permit with existing ordinances and all pertinent fishery laws;

SECTION 5. The application, clearance/permit or the denial thereof, including such other documents as may be pertinent in the implementation of this ordinance shall be in the forms prepared by the Municipal Agricultural Office;

SECTION 6. For the issuance of clearance/permit required under this ordinance, the application fee of twenty-five pesos (P25.00) shall be charged;

SECTION 7. Any person who fails to secure the clearance or permit required by this ordinance shall be denied by the Municipal Mayor with fishing Permit;

SECTION 8. Any person who shall continue to fish at this Municipality without Fishing Permit from the Municipal Mayor and permit/clearance from the Municipal Agricultural Officer or shall violate any provision of this ordinance shall be punished by a fine of Two Thousand and Five Hundred Pesos (P2,500.00) or by an imprisonment of six (6) months or both such fine and imprisonment at discretion of the Court;

SECTION 9. Ordinances ^{inconsistent} hereof are hereby repealed, modified accordingly;

SECTION 10. This ordinance shall take effect ten (10) days after its posting;
