AN ORDINANCE AMENDING SECTION 4G.01, ARTICLE G OF THE REVISED REVENUE CODE OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro; that:


SECTION 1. Section 4G.01, Article G of the Revised Revenue Code of Bulalacao, Oriental Mindoro is hereby amended to read as follows:

Section 4G.01. Imposition of Fee. There shall be collected for the issuance of a clearance or certification by any offices of the municipal government the following fees:


- 1. Certification/Clearances for purposes of entering the military service . . . . . ₱10.00
- 2. Certification/Clearances to be used in securing a driver's license . . . . . 20.00
- 3. Certification/Clearance for purposes of securing a passport or visa . . . . . 20.00
- 4. Certification/Clearance for the purpose of securing or renewing a license to possess firearms . . . . . 50.00
- 5. Certification/Clearance for other purposes not mentioned above . . . . . 20.00


SECTION 2. This Ordinance shall take effect ten (10) days after its posting.
