" RESOLUTION NO. 95-02-010

REQUESTING THE SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS
AND HIGHWAYS (DPWH) THRU ITS REGIONAL DIRECTOR TO AWARD TO
THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO THE
MAINTENANCE OF NATIONAL ROADS AND BRIDGES SITUATED AT THE
LATTER'S JURISDICTION

"WHEREAS, it is aptly observed by the public that the
usual practice, as authorized by law, of awarding the main-
tenance of national roads and bridges to the private con-
tractors by the DPWH has been shortchanging the government to
the detriment of the taxpayers;

"WHEREAS, likewise this practice of awarding the main-
tenance of national roads and bridges also proved to be
costly in terms of financial resources for apparently the
services and the subsequent results made by these contrac-
tors were below par compared to what actually contained in
the programs of works;

"WHEREAS, despite the continued maintenance of these
national roads and bridges, motorists and pedestrians
alike have to suffer the inconvenience brought about by the
sorry conditions of these roads and bridges;

"WHEREAS, it is still fresh on the memory of the pub-
lic the condemnable collapse of one of the national bridges
here as a result of the substandard work of one of those
private contractors whose primary concern was to amass more
profits out of the projects awarded to them;

"WHEREAS, considering this lamentable condition and
realizing the practical advantages, if and when the main-
tenance of these national roads and bridges is awarded to
the municipal government, the latter through this Sanggu-
nian contemplated to request the DPWH to award the same
to the municipal government of Bulalacao, Oriental Mindoro;

"WHEREAS, what encouraged this Municipality to make this proposal are the following;

1. That the municipal government now employs four (4) engineers equipped with the technical know-how in carrying out the required job;
2. That through sheer thriftiness and proper fiscal management, the municipal government was able to acquire some heavy equipments such as dumptruck and pay-loader; and planning to acquire a new grader before 1995 expires;
3. More importantly, the genuine aspiration of the local officials to improve the transportation system in this part of the nation is the most essential singular reason why it is convinced that the awarding of maintenance of national roads and bridges to the municipal government will reap benefits in favor of its constituents;








