“WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that basic and quality education be made accessible to all;


“WHEREAS, it is believed that education ensures all possible conditions for the fullest development of the students given the right opportunities and enough facilities to achieve education goals;
