AN ORDINANCE AMENDING SEC. 3(a) OF MUNICIPAL ORDINANCE NO. 19-09-244 ENTITLED "AN ORDINANCE CREATING THE MUNICIPAL COOPERATIVE DEVELOPMENT COUNCIL IN BULALACAO, ORIENTAL MINDORO, PRESCRIBING ITS FUNCTIONS, APPROPRIATING FUNDS FOR ITS OPERATION, AMONG OTHER PURPOSES"


- c. Municipal Cooperative Development Officer

SECTION 2. This Ordinance shall take effect immediately.




