7,000.00 is reverted P 7,000.00




NOW, THEREFORE, resolved as it is hereby resolved, to revert

CAPABILITY-BUILDING PROGRAM of this municipality;


RESOLVED, FURTHER, that copies of this Resolution be furnished,

There having no other business to be taken-up, so on motion of Councilor Nenito S. Ambong, seconded by all the members present, session is adjourned at 12:00 noon;


