**RESOLUTION NO.12-08-057**

**RESOLUTION APPROVING THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT PROGRAMS, PROJECTS AND ACTIVITIES (PRE-DISASTER PLAN) FOR FISCAL YEAR 2012 OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS,** Section 21 of Republic Act No. 10121 otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 provides that five percent (5%) of the estimated revenue from regular sources shall be set aside as the Local Disaster Risk Reduction Management Fund (LDRRMF) to support disaster risk management activities such as, but not limited to Pre-disaster preparedness programs including training, purchasing life saving rescue equipment, supplies and medicines, for post-disaster activities and for the payment of premiums on calamity insurance; Section 21, also provides that of the amount appropriated for LDRRMF, thirty percent (30%) shall be allocated as Quick Response Fund (QRF) or stand-by fund for relief And recovery program in order that situation and living condition of people in communities or areas stricken by disaster calamities, epidemic or complex emergencies, may be normalized as quickly as possible. It can be construed from the above provisions of the law that the remaining seventy percent (70%) of the amount appropriated for LDRRMF can be utilized to support disaster risk management activities such as pre-disaster preparedness program, post-disaster activities and payment of premium on calamity insurance;

**"WHEREAS,** the Municipal Risk Reduction Management Council has prepared and submitted programs, projects and activities to be funded from the 70% of the Local Disaster Risk Reduction Management Fund (LDRRMF) to wit:
