EARNESTLY REQUESTING THE DEPARTMENT OF AGRICULTURE THRU SECRETARY EMMANUEL PINIOL TO ALLOCATE THE AMOUNT OF TEN MILLION PESOS (PHP10M) TO BE USED FOR THE CONSTRUCTION OF NEW AND MODERN MUNICIPAL SLAUGHTERHOUSE IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 that because of financial constraints could not readily implemented important infrastructural projects particularly those which are income generating such as that of a modern slaughterhouse;

“WHEREAS, a modern double “AA” accredited slaughterhouse with upgraded facilities that conform to Good Manufacturing Practice (GMP) based on standards set by the National Meat Inspection Service (NMIS) that shall service the domestic market is profitable for this Pro-Poor Municipality in order to enhance the operations and the capability to supply higher quality and safe meat and meat products;









