“**WHEREAS**, the FY 2022 Annual Budget of Barangay Maasin was duly taken by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session on June 27, 2022 and was found to be consistent with pertinent laws, rules and regulations;

“**WHEREAS**, the Sangguniang Barangay of Maasin, Bulalacao, Oriental Mindoro is likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached review letter which became integral part of this resolution;






