RESOLUTION NO. 18-02-027

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2018 OF BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF ONE MILLION SIX HUNDRED SEVEN THOUSAND THREE HUNDRED EIGHTY FIVE PESOS AND EIGHTY FIVE CENTAVOS (PHP1,607,385.85) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2018-01 DATED NOVEMBER 6, 2017

“WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, the Sangguniang Barangay of Maasin, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2018 showing therein the sources of income and barangay expenditures starting from January 1, 2018 up to December 31, 2018;

“WHEREAS, the Barangay Fund Annual Budget for FY 2018 of Barangay Maasin was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on February 9, 2018 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be fully implemented and should not be realigned to any other projects;

"WHEREAS, Local Budget Memorandum No. 75-A clarifies that the Internal Revenue Allotment (IRA) of Barangay Maasin is One Million Five Hundred Seventy Eight Thousand Seven Hundred Sixteen Pesos (PhP1,578,716.00), hence, necessary adjustment conforming to such amount must have to be undertaken;

"WHEREAS, Sangguniang Barangay of Maasin, Bulalacao, Oriental Mindoro is likewise advise to strictly follow the recommendation of the Local Finance Committee as reflected in the review letter attached herewith;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulation; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED To: Approve the Barangay Fund Annual Budget for FY 2018 of Barangay Maasin, Bulalacao, Oriental Mindoro appropriating the amount of One Million Six Hundred Seven Thousand Three Hundred Eighty Five Pesos and Eighty Five Centavos (PhP1,607,385.85) passed under Appropriation Ordinance No. 2018-01 dated November 6, 2017;
