RESOLUTION REQUESTING THE DISTRICT ENGINEER, MINISTRY OF PUBLIC WORKS, CALAPAN, ORIENTAL MINDORO, THE CONSTRUCTION OF THE BULALACAO WATER WORKS SYSTEM, BULALACAO, ORIENTAL MINDORO

WHEREAS, the problem of the people of Poblacion, Bulalacao, Oriental Mindoro is lack of water supply;

WHEREAS, one of the causes of lack of water supply in this town is that the Reservoir is small and could not hold plenty of water and the pipes are also small hence delayed the distribution of water;

WHEREAS, bigger and larger Reservoir of this town need to be constructed in order to have plenty of water supply;

WHEREAS, 6 Inc. X 6 meter water pipes are also needed so that the distribution of water will be sufficient;

NOW THEREFORE, resolved as it is hereby resolved to request the District Engineer, Ministry of Public Works, Calapan, Oriental Mindoro, the construction of Reservoir of Bulalacao water supply to a bigger one and to change the water pipes with 6 inc. X 6 meter so that the distribution of water will be sufficient;

RESOLVED, FURTHER, that copies of this Resolution be furnished the District Engineer, Ministry of Public works, Calapan, Oriental Mindoro for consideration;
