" RESOLUTION NO. 93-10-061

RECOMMENDING THE CREATION OF SITIO DANGKALAN AS A NEW BARANGAY OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, Sitio Dangkalan has signified its strong desire of becoming a new barangay, through the petition of the Council of Tribal Leaders forwarded to this body;

"WHEREAS, Sitio Dangkalan is populated by Hanunuo Mangyan, lead by tribal leaders who were chosen by majority of the inhabitants and are governed by their traditional laws, mores and beliefs;

"WHEREAS, the Local Government Code of 1991 provides that notwithstanding the population requirement, a barangay may be created in the indigenous cultural communities by Act of Congress upon recommendation of the local government unit where the cultural community is located;

"WHEREAS, the creation thereof will redound and contribute greatly to the stability of economic, political and social conditions of the residents of this proposed barangay;

NOW THEREFORE: RESOLVED AS IT IS HEREBY RESOLVED that the creation of Sitio Dangkalan as new barangay of Bulalacao, Oriental Mindoro be recommended to the Congress of the Philippines;

RESOLVED FURTHER, that copies of this Resolution be furnished Hon. Jesus M. Punzalan, Congressman District II, Oriental Mindoro, House of Representatives, Diliman, Quezon City and the Sangguniang Panlalawigan, Calapan, Oriental Mindoro, for their information and appropriate action.
