RESOLUTION NO. 06-02-026

ACCEPTING AND AFFIRMING THE RELINQUISHMENT OF RIGHT TO OPERATE, ESTABLISH AND MAINTAIN THE COCKPIT AT SITIO CAWACAT, BARANGAY CAMBUNANG, BULALACAO, ORIENTAL MINDORO BY MR. CHARLIE SANCHEZ AND THAT THE ISSUANCE OF LICENSE SHALL BE OPENED TO ALL INTERESTED, WILLING AND QUALIFIED INDIVIDUALS

"WHEREAS, the Sangguniang Bayan is empowered under Section 447 par. 3 (v) to grant licenses and may regulate, authorize and license the establishment, operation and maintenance of cockpits, regulate cockfighting and the commercial breeding of gamecocks;

"WHEREAS, such provision of the same law provides that "existing rights should not be prejudiced" however, Mr. Charlie Sanchez relinquished the same for lack of interest;

"WHEREAS, through a letter by former Mayor Dolores S. Bago, dated January 10, 2008, such profound interests in maintaining, establishing and operating a cockpit was favorably considered by this Body; Now, therefore, be it


