FIXING THE RENTAL FEE FOR THE USE OF KUBOTA MINI FARM TRACTOR WITH EXCAVATOR WHICH IS OWNED AND MAINTAINED BY THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

SECTION 1. The rental fee of the Kubota Mini Farm Tractor with Excavator owned and maintained by the Municipality of Bulalacao, Oriental Mindoro to any interested person is hereby authorized and fixed at One Hundred Pesos (P100.00) per hour;

SECTION 2. The leasee shall be responsible for the fuels and lubricants of this farm machinery within the duration of the work covered by the rental fee;

SECTION 3. The Municipal Treasurer or his duly authorized representative shall issue an official receipt as evidence of payment of rental imposed herein. The same shall be presented by the applicant to the Municipal Agricultural officer before the farm equipment mentioned herein can be actually used;




SECTION 4. This ordinance shall take effect immediately.




