REQUESTING THE MINISTER, MINISTRY OF NATURAL RESOURCES, QUEZON CITY TO RELEASE FOR AGRICULTURAL PURPOSES, THE PASTURE LANDS OF MESSERS FLORENCIO MORALES AND OSCAR SOLIT, LOCATED AT NAPISIAN AND TUHOG DANUM, BARANGAY CAMBUYANG, BULALAGAO, ORIENTAL MINDORO, RESPECTIVELY

WHEREAS, Messers Florencio Morales and Oscar Solit had owned pasture lands located at Barangay Cambunang, this municipality;

WHEREAS, these pasture lands had been abandoned and no large cattles nor minor animals could be found therein;

WHEREAS, these pasture lands are suited for agricultural purposes;

WHEREAS, there were qualified tenants, now residing inside these pasture lands, cultivating the same and planting different kinds of crops for their livelihood;

NOW, THEREFORE, resolved, as it is hereby resolved to request, the Minister, Ministry of Natural Resources, to release the Pasture lands of Messers Florencio Morales and Oscar Solit for Agricultural purposes, and to be distributed to qualified tenants;
