**SPECIAL ORDINANCE NO. 17-02-09**

**AN ORDINANCE GRANTING MONTHLY COMMUNICATION ALLOWANCE TO INCUMBENTS OF MARKET ADMINISTRATOR AND COMMUNITY AFFAIRS COORDINATOR DESIGNATIONS AND SANITARY INSPECTOR I AND NURSE II POSITIONS IN THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1. STATEMENT OF POLICY.** It is the policy of the Local Government Unit of Bulalacao, Oriental Mindoro (LGU of Bulalacao) to maintain empowered, high morale, and productive workforce. The Sangguniang Bayan of Bulalacao is tasked by the Local Government Code of 1991 to determine salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds.

**SEC. 2. ENTITLEMENT.** The incumbents of the following designations or positions in the LGU of Bulalacao shall receive monthly communication allowance as stated:

*(Handwritten signatures and initials)*

- a. Market Administrator - PhP 3,000.00
- b. Community Affairs Coordinator - PhP 3,000.00
- c. Sanitary Inspector I - PhP 2,200.00
- d. Nurse II - PhP 2,200.00

In case there will be creation of new positions, the highest ranking position created shall receive the monthly communication allowance. Incumbents of cited herein designations or positions who shall incur unauthorized absences or who shall be on leave of absence for at least ten (10) calendar days shall not receive this benefit proportionate to the number of days absent. The acting officer/employee or in-charge of office, if applicable, shall instead become the recipient until the return to office of the concerned official or employee.

The concerned employees shall start receiving this allowance immediately upon assumption to duty.

**SEC. 3. NON-INCLUSION IN INCREASE.** Incumbents of designations or positions stated herein shall not be covered by PhP 1,000.00 across the board monthly increase of this allowance effective January 01, 2017 as mentioned in Section 3 of Special Ordinance No. 16-09-41.

**SEC. 4. FUND.** Funding for this shall be prioritized in appropriating the 2016 budget surplus of LGU of Bulalacao through Supplemental Budget No. 1 for 2017. Thereafter, there shall be annual allocation for this allowance in the Office of the Municipal Mayor (for Market Administrator and Community Affairs Coordinator) and Municipal Health Office (for Sanitary Inspector I and Nurse II) under communication expense budget and accounting code covered by maintenance and other operating expenses.

**SEC. 5. FUND DISBURSEMENT.** Disbursement shall only be allowed upon presentation of statement of account or official receipt of payment for communication expense issued by legitimate retailer or dealer of communication services or products.


**SEC. 6. REPEALING CLAUSE.** Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

**SEC. 7. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect.

**SEC. 8. EFFECTIVITY.** This Ordinance shall take effect immediately after the approval of the Municipal Mayor.




