WHEREAS, the town of Bulalacao is classified as one of the PRO-POOR
Municipalities throughout the country;

WHEREAS, the Municipal Government of this town cannot implement tax
collection campaign to increase revenues due to Insurgency problem;

WHEREAS, salaries of Municipal officials and employees was increased
only to 45% under Circular No. 36 for CY 1991 and was not increased this
year 1991 due to lack of funds;

WHEREAS, due to high prices of prime commodities standardization of
salaries of Municipal employees of this town to its maximum rate under
Circular 36 is indispensable;

NOW, THEREFORE, resolved as it is hereby resolved, to request the
Regional Director, Department of Budget and Management, Quezon City to
increase the Internal Revenue Allotment of the municipality of Bulalacao,
Oriental Mindoro for CY 1991 so as to implement standardization of salaries
of Municipal officials and employees under Circular 36;
