**"WHEREAS**, the Philippine Military Academy (PMA) in the Philippine Military School of the Armed Forces of the Philippines (AFP) established on December 21, 1936 by the virtue of Commonwealth Act No. 1 or the National Defense Act. It is located in Baguio City and serves as the training school for future officers of the AFP;

**"WHEREAS**, the PMA adopts a holistic view of a man, soul and spirit. PMA believes that future leaders can be selected, formed and developed to their fullest potentials. PMA is principally an institution for military leadership and it is from a total view of a man that PMA's leader development program is based. It contains character development, a balanced college education, military leadership and physical development necessary to prepare the cadets for the profession of arms and to be responsive to the needs of the Armed Forces and the Nation;


**"WHEREAS**, every Filipino youth aspire of becoming a PMA Cadet because of the privilege and honor of serving the country, free college education, monthly salary and allowances, state of the art training facilities and a rewarding career as an officer of one of the branches of the Armed Forces of the Philippines;


"WHEREAS; this resolution is inspired by PMA Cadet, Joram Eli Contreras Harina who recently graduated from the Academy. He is a resident of Bulalacao, Oriental Mindoro, the first ever Bulalacaonon who was admitted and graduated from PMA to which his family, relatives and friends are all proud of him; Now, therefore, be it
