EARNESTLY REQUESTING GMA NETWORK, KAPUSO DEVELOPMENT FOUNDATION, THROUGH MS. MEL TIANGCO, EXECUTIVE DIRECTOR, TO PLEASE EXTEND ITS CHARITABLE ASSISTANCE FOR THE CONSTRUCTION OF ONE UNIT OF THREE-ROOM SCHOOL BUILDING FOR THE BENEFIT AND WELFARE OF INDIGENOUS AND POOR STUDENTS OF BULALACAO NATIONAL HIGH SCHOOL-CABUGAO ANNEX, BARANGAY CABUGAO, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, education is seen as a solution being one of the pillars of any poverty reduction strategy but because of its location, Barangay Cabugao is only one of those upland barangays that does not get fair share in the basic services provided by government and sadly excluded from socio-economic growth happening in the lowlands;

"WHEREAS, the stark reality of getting and providing education in Cabugao is a heart rending sight where lowly-paid teachers teach their pupils and students who generally come from extremely poor and indigenous families under the roof of a dilapidated buildings bereft of the necessary facilities we can consider conducive to learning; much more due to fast-growing population it is not uncommon to see that these young people take their lessons under the shade of mango trees;

"WHEREAS, Christian and Mangyan children alike share the same usual experience in this place; malnutrition, unemployed parents, lack of school supplies and other instructional materials worse their right to quality education is doubly magnified by lack of a decent school room where they could web their dreams of being freed from this perennial poverty;


"WHEREAS, the benevolence of Ms. Mel Tiangco is manifested and widely recognized through the thousands of young people all over the country who were benefited through, her KAPUSO Development Foundation, eager and deeply motivated by her concern to the helpless, that people without hesitation take the courage to make a request hoping that somehow they will share the fortune of getting educational assistance from the Foundation. Now, therefore, be it.


