“WHEREAS, Sunday, April 21, 2024, a supposedly ordinary day surprised everyone as one of the most-loved leader and medical practitioner in Bulalacao, Dra. Imelda F. Ramos, bid her final goodbye as she was removed from our midst by sudden death and reunited with our Almighty God which caused a deep void of sadness to his family, friends and colleagues;

“WHEREAS, Dra. Ramos, was a loving mother for her three children and a very supportive wife to her husband for which they built a beautiful and God-centered family, but regrettably she transposed to become a memoir of a most-cherished person as she suffered from a severe illness and died at the age of 63 years old;

“WHEREAS, Dra. Ramos' success in the medical field was evident to many, she started her service as Medical Officer III in Roxas District Hospital on February 10, 1992 until she was transferred to the Provincial Government on January 1, 1993, she was then promoted as Rural Health Physician on September 1, 1993 and officially became the Municipal Health Officer of the Municipality of Bulalacao on February 15, 1994, for more than three decades she was remembered as a compassionate and enthusiastic doctor who effectively provided medical care and treatments to Bulalacaonons at all corners of the municipality;
