"WHEREAS, vermiculture is a more organic way of producing fertilizer from readily available agricultural wastes in the farm and organic households refuse, it supports the Republic Act 9003 otherwise known as the Ecological Solid Waste Management Act of 2001 which strategically envisions that all stakeholders, whether government institutions, private entities in commercial/industrial establishments, and every household must implement the solid waste management scheme;


