RESOLUTION NO. 17-08-190

RESOLUTION REQUESTING THE ORIENTAL MINDORO ELECTRIC COOPERATIVE (ORMECO) THRU GENERAL MANAGER, ENGR. PATROCINIO PANAGSAGAN TO INFORM IN WRITING THE LOCAL GOVERNMENT UNIT OF BULALACAO THRU THE OFFICE OF THE MUNICIPAL MAYOR AND THE OFFICE OF THE SANGGUNIANG BAYAN ON THE REASONS WHY THE MUNICIPALITY OF BULALACAO IS ALWAYS THE LEAST OF PRIORITY DURING LOAD SHEDDING

"WHEREAS, electricity is one of the most important blessings that science has given to mankind. It has also become a part of modern life that one cannot think of a world without it for it provides comfort and entertainment to every home;

"WHEREAS, electricity becomes indispensable in the establishment and operation of various industrial plants and factories, hospitals, schools and other business and commercial centers which clearly shows that electricity plays a vital role in the pursuit of social and economic development;

"WHEREAS, during the appearance of certain ORMECO personnel led by Engr. Elmer Bautista and Engr. Andres Zamora in the regular session of the Sangguniang Bayan of Bulalacao on June 9, 2017, issues affecting power interruption were discussed such as shortage in supply and the destruction brought by Typhoon Yolanda however, along with this, they mentioned various strategies to minimize brown-outs particularly in ROMANBUL areas such as the installation of emergency power facility and load shedding;

"WHEREAS, lately, it was observed that the Municipality of Bulalacao is experiencing series of brown-outs for a longer time daily that really made our constituents irritated and angrily questioned the municipal officials to act on the matter so that this resolution was urgently passed and approved;

"WHEREAS, for the social and economic benefits of our people, this Sanggunian humbly asked for a written explanations why Bulalacao is the least priority in load shedding because it is understood that power shortage could not be readily resolved at the moment for us to understand and likewise explain to our constituents; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Oriental Mindoro Electric Cooperative (ORMECO) thru General Manager, Engr. Patrocinio Panagsagan to inform in writing the Local Government Unit of Bulalacao thru the Office of the Municipal Mayor and the Office of the Sangguniang Bayan on the reasons why the Municipality of Bulalacao is always the least of priority during load shedding;
