REQUESTING THE EACH ONE, FEED ONE, TEACH ONE FOUNDATION TO PROVIDE RAIN COLLECTORS TO BANTI ELEMENTARY SCHOOL, LIBTONG HIGH SCHOOL, NAMALAYAN HIGH SCHOOL, GATOL HIGH SCHOOL, AGONG ELEMENTARY SCHOOL, DANGKALAN ELEMENTARY SCHOOL, SAN ROQUE ELEMENTARY SCHOOL AND LIBTONG ELEMENTARY SCHOOL, ALL IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, pursuant to the Philippine Constitution, the State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all. Furthermore, the State shall establish, maintain and support a complete, adequate and integrated system of education relevant to the needs of the people and society;

"WHEREAS, majority of the enrollees in the abovementioned schools are hanunuo mangyans living in the hinterland devoid of modern technologies lowland communities are enjoying. Most of these areas do not have electrification facility therefore, absence of electrical appliances and fixtures, no appropriate and sustainable water system and lack of an all-weathered road to facilitate shipment of goods and movement of people;

"WHEREAS, everybody would agree that water is essential to everyday living that every household hopes for its availability and sustainability. The same shall be provided for all schools but due to financial constraints by the Local Government Unit of Bulalacao being the Pro-Poor Municipality in addition to the expenses incurred by the spread of Covid-19, the need for an efficient water system could not be readily funded;


"WHEREAS, the best alternative method, these mangyan schools could make is by collecting rain water where a rain collector of any kind is an urgent need taking advantage of the coming of rainy season; **Now, therefore, be it**


RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Each One, Feed One, Teach One Foundation to provide rain collector to Banti Elementary School, Libtong High School, Namalayan High School, Gatol High School, Agong Elementary School, Dangkalan Elementary School, San Roque Elementary School and Libtong Elementary School, all in the Municipality of Bulalacao, Province of Oriental Mindoro;
