SPECIAL ORDINANCE NO. 12-08-18

SPECIAL ORDINANCE TRANSFERRING THE INTERNAL REVENUE ALLOTMENT (IRA) FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO FROM LAND BANK OF THE PHILIPPINES (LBP), PINAMALAYAN BRANCH TO LBP ROXAS BRANCH, ROXAS, ORIENTAL MINDORO, AND FOR OTHER PURPOSES

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. In order to achieve more effective, efficient and practical usage of the local funds, the Internal Revenue Allotment is hereby authorized to be transferred from Land Bank of the Philippines (LBP), Pinamalayan Branch to LBP Roxas Branch, Roxas, Oriental Mindoro thereby giving authority to the Department of Budget and Management and other concerned local officials to cause the necessary actions hereof;






