The session was called to order at 9:30 in the morning.

The calling of the roll was performed by the Secretary with the members answering present when their respective names were called.

The minutes of the previous session was also read and there no objection so on motion of Hon. Emelio Gregorio, seconded by Hon. Wilfredo Alejandro, the minutes stands as confirmed.

SB member Wilfredo Alejandro, in his privilege speech allege that all municipal streets in this town should bear its respective names to be placed in every corner for proper identity.. UNANIMOUSLY APPROVED:

OIC Mayor Guillera H. Salas, suggested to hold a joint special session of Sangguniang Bayan and Barangay Captains on October 13. The purpose of this joint special session is for barangay Captains to voice out the problems affecting the livelihood and peace and order situation in their respective barangays... UNANIMOUSLY APPROVED

SB member Roland Pagcaliwagan in his short deliberation also said that there are fish and corn dealers in Barangay San Roque which do not have Mayor's License or permit who engage in buy and sell.

At this juncture SB Pagcaliwagan requested the Sangguniang Bayan to deputize him through Resolution was Tax Collector so that he can properly impose taxes in Barangay San Roque. . . UNANIMOUSLY APPROVED

SB member Sanny Madra also pass an Ordinance to require meat vendors in this town to pay ₱0.30 per kilo of meat to be sold in the Public market..

The Sangguniang Bayan ordered the Municipal Secretary to write all Barangay Captains in this municipality to attend the joint special session on the 13th day of this month as set by them..

RESOLUTION NO. 61 ✓

REQUEST FOR THE INCLUSION IN THE REPAIR PROGRAM FOR FISCAL YEAR 1987 OF THE TWO THREE-ROOM BUILDINGS OF BULALACAO, ~~CENTRAL SCHOOL~~, BULALACAO, ORIENTAL MINDORO

WHEREAS, at the instance of the Principal of Bulalacao Central School the Sangguniang Bayan of Bulalacao was prompted to conduct an ocular inspection of the status or condition of the buildings and or classrooms of the said school;

WHEREAS, two three-room buildings were found to be hazardous to the schooling pupils. Their lamentable condition may be gleaned from the following situation:

- a. Roofings have no tying wires with large stones used as wights in order to keep the galvanized irons intact; Roofs leaking;
- b) Shutters of doors are only held by wires;
- c. The dividers are delapidated due to termite attack and water from the leaking roofs;
- d. Flooring is full of cater-like holes;
- e. No ceilings; and;
- f. paint washed out and iron grills eaten-up by rust;

WHEREAS, the Sangguniang Bayan of Bulalacao sees it fit and imperative to remedy the moribund state of these buildings but, they are not in a position to give any financial aid for the repair of these buildings;

NOW, THEREFORE, the Sangguniang Bayan of Bulalacao, Resolves, as it is hereby Resolved, to request the Ministry of Public Works and Highways to include these two buildings in its program of repair for the fiscal year 1987;

RESOLVED, FURTHER, that copies of this resolution be furnished the District Engineer, MPWH, for consideration, and the School building Committee, MECS, all of Calapan, Oriental Mindoro for their information, guidance and reference.

On motion of Hon. Roland Pagcaliwagan, duly seconded by Hon. Emelio Gregorio, this Resolution was... UNANIMOUSLY APPROVED.

There having no other business to be transacted so on motion of Hon. Roland Pagcaliwagan, seconded by Hon. Sanny Madra, the session was adjourned at 12:20 in the afternoon.
